Users

The Can Palós Scout Centre can be used by all individuals and / or organizations who have consulted the availability and have made reservation by phone 93.590.27.00 or via the web form found at www.centresescoltes.cat website.

The person responsible of Can Palós Scout Centre

It is the person who exercises the highest authority in the Scout Centre Can Palos.

His/her decisions, both with regard to the implementation of this regulation and for the things that have not been foreseen, are inexcusable compliance. Notwithstanding, if subsequent claims they will be studied.

The Can Palos' responsible, should attend users as guests and their behavior will continue in any case the basic standards of hospitality.

This person will be responsible for:

- a) Organizing accommodation.
- b) Admitting and identifying users.
- c) Ensuring the safety, cleanliness and good shelter.
- d) Respecting the order necessary for the general interest.
- e) Letting know the operation of the center and its terms of use.

In case of accident or exceptional circumstances, this person will collaborate in everything and will facilitate the rescue work.

Reservations overnight

In order to achieve better use of the Scout Centre is required to book in advance.

To that effect, the head of the Centre and central reservations must confirm the reservation. In any case, confirmed reservations will be maintained only until 19:30h the day concluded.

Price lists

The price lists for various services provided will be exposed to the view of users and is also available in the central reservation www.centresescoltes.cat.

General rules binding

For the proper functioning of the Scout Centre, it is necessary that all people using the centre put the utmost care in their conservation and use of services, equipment and supplies available. Users will also ensure that cause minimal environmental impact (saving resources and damaging the environment) for user safety and proper use of the facilities.

To this end, and in order to achieve better respect for others, the organization has established the following rules:

a) Users

• All children must always be accompanied during the entire duration of the stay by the responsible person of the group



- The responsible person is the one that ensures the proper use by people attending both the facilities for the proper functioning of the stay and the safety of people in the group / collective that is under its responsibility.
- In case of illness or accident, medical services and medicines will be provided by the responsible of the group, as well as the corresponding legal responsibility.
- Liability is always the head of the group or user to carry out the activity or stay on the premises.
- The users must identify themselves by completing check-ins that provide the person responsible for the equipment. To this end, and agreed with Article 20.2 of Decree 140/2003, you must:
 - o If the user is an organization: to identify and record the data of the person (or persons) responsible for the group of age (ID, name, town)
 - In the case of home users: must properly identify themselves using ID, passport or driving license and record the data (ID, name, town) in the Record Book, all of legal age and also relate to minors (ID not required in this case)

b) It is strictly forbidden:

- Turning off heat or cooking outside the places designed specifically for this purpose.
- Smoking inside the house, as the law in force already stipulates.
- Consuming alcoholic beverages, drugs, narcotics or psychotropic substances
- Any kind of celabration of groups with less than 25 years.
- Using of all types of audio devices that could disturb other users.
- Entering any kind of animal.
- Eating and drinking in bedrooms.
- Removing the covers outside the house.

c) It is necessary that all users of the Scout Centre:

- Let the tools used completely clean and picked up.
- Respect the safety standards.
- Collect all the garbage and waste generated both inside and outside the house and deposited it in the appropriate containers.
- Leave the covers folded and tidy when leaving.
- Close all perfectly lights, doors and windows every time you leave the Scout Centre.
- Be silent from 0.00h to 7.00h.
- It is necessary to access to the Scout Centre with as few vehicles as possible, cause the parking space is limited.

d) Damage and misuse of equipment and installations

To ensure that users make proper use of the facilities it is provided that:

- You must pay a deposit (as specified in current prices) at the time of arrival. This deposit will be returned at the time of departure, after review of the installation and if it is not observed any damage to furniture, equipment and installation and if the equipment is left clean and picked up.
- If damage is detected or not fulfilled the previous point regarding the order and cleanliness, the amount of the deposit will be retained and it will return the portion left, if there is any, after completing repair.
- If the cost of repairs made exceed the amount of the bond, the person responsible for the stay will make the settlement of the remaining amount immediately after receiving the invoice.



In case of serious breach of the rules of general use by anyone using the Scout Centre, the responsible person can force people to leave the Scout Centre.

Acceptance of these regulations

Using the Scout Centre Can Palos implies the acceptance of these rules, which will be exposed in the center and will be delivered and signed at the time of the reception of the person responsible for the stay and users of the center.
